- 1. Be a Hindu; (Management Committee may also consider other deserving & needy non- Hindu applicants).
- 2. Be a Singapore Citizen, child of a Singapore Citizen or Singapore Permanent Resident.
- 3. Currently studying in Primary, Secondary or a Government Aided School, located in the vicinity of the temple or in a Tertiary institution (under MOE) in Singapore.
- 4. Be from a household with per capita income of \$1200 or less.
- 5. The MC may also consider other deserving applicants on a case-by-case basis, e.g. a child of parent(s) who actively volunteers at SRKT.

Application and Award:

1. The application must be duly completed and submitted before 9.00 pm on 30th November 2025 with photocopies of all supporting documents. You may also e-mail the completed application and the supporting documents as one merged document, in a pdf format.

- e. Tertiary students must submit status letters from the institution they are enrolling in.
- f. Latest pay slips or any other proof of gross monthly income of parents and other family members in the same address. In the absence of pay slips, or in case one or both parents are not employed, latest CPF contribution statements or latest IRAS income tax statement is required as proof of income.
- Q. Any other document(s) to establish the need for support.

Failure to submit copies of any of the above documents would result in rejection of the application.

- 2. The awards will be presented to the successful applicants at the Scholarship & Bursary Award Ceremony.
 - a. All applicants must attend the ceremony personally to receive the bursary award, failing which the award shall be forfeited, unless there is a valid reason for absence acceptable to SRKT.
 - b. All award recipients must attend in full school uniform.
 - C. Award recipients will be paid electronically. We will require the recipients' bank account / other relevant details before payment can be processed.
